Program: Access from AT&T

Details:

- Up to \$10 per month (plus taxes)
- 10 Mbps
- No term commitment
- No deposit
- No installation fee
- In-home Wi-Fi modem included

To Qualify:

- **COVID-19 Response: No termination regardless of ability to pay, waive late payment fees due to inability to pay, and keep public wifi hotspots open for those who need them.**

- Eligibility based on income and to households participating in National School Lunch Program/Head Start, Supplemental Nutrition Assistance Program (SNAP or food stamps) or that receive Supplemental Security Income (CA residents only).

- At least one person in the applying household must be a K-12 student who participates in the National School Lunch Program; receive HUD housing assistance; participate in the Supplemental Nutrition Assistance Program (food stamps); receive Supplemental Security Income; be a veteran who receives federal or state assistance; or participate in other programs.
- Applicant must not have subscribed to Comcast's internet service within the last 90 days, have an overdue Comcast bill or unreturned equipment from within the past year.

- *Households with children participating in the National School Lunch Program and people 65 years or older receiving Supplemental Security Income (SSI) should ask to enroll in Spectrum Internet Assist in order receive two months of free service and remain on the low-cost plan (\$17.99-\$23.99/mo) after the two month promotion ends.*
- At least one person in the applying household must participate in the National School Lunch Program (NSLP), Community Eligibility Provision (CEP) program, or receive Supplemental Security Income (≥ 65 age only). Current Spectrum Internet subscribers are not eligible.
- Applicant must not be a current Spectrum internet customer, subscribed to Spectrum internet service in the last 30 days or have outstanding Spectrum bills.

Eligibility for and availability of internet service are confirmed during the application process. You may read all the eligibility requirements and internet service details on the ISPs' websites.

Program

Requirements

The **T-Mobile ConnectHome Plan** is donating devices (tablets and hotspots), while supplies last, to public housing authorities, schools, libraries, and nonprofits to help bridge the digital gap for K-12 students. Participating organizations must purchase Internet plans.

- Two year program. Plans must remain active for two years;
- Plans starting at just \$10.00 for 2GB of high speed data on 4GLTE network;
- No cost filtering solution with four access levels to protect your students;
- No overage fees;
- On-site and no cost implementation services from experienced wireless professionals;
- On-site and no cost sales engineering support; and
- No cost LTE signal boosters if needed within the home for government liable users.

School districts and public housing authorities with students without Internet access at home must meet the following requirements:

- Be a Title 1 school (not applicable to public housing authorities)
- Commit to maintaining devices active for two years;
- Submit W-9;
- Submit Tax exempt certificate; and
- Select devices: Tablet , Hotspots, Chromebooks or combination

Kajeet, a national organization, is dedicated to supporting educational growth of K-12 students by providing reliable Internet service. Kajeet works with school districts to identify and deploy Internet service solutions for students. The Kajeet SmartSpot solution is a WiFi hotspot compatible with many laptop, tablets, Chromebooks and other devices that allows students to connect to the Verizon or Sprint 4G LTE networks. Kajeet offers two Educational Broadband plans that can be customized to meet school district budget constraints, staff capacity, and other needs. Features include (as listed on the Kajeet website):

- Plans start as low as \$9.99 for 6GB of high speed data;
- Fully CIPA-compliant and filtered for education-only content;
- On-device menu screen and navigation keys allow the user to easily scroll through menus to get critical information-at-a-glance;
- Compatible with all industry-standard Wi-Fi capable devices across all operating systems;
- Up to 10 students can connect to the device under the Customer Managed Service Model;
- Easy view battery strength, signal strength, connected devices, password and more;
- Long battery life provides up to 8 hours* of use on a single charge, and customizable settings in a Web UI provide features such as screen sleep settings to help extend the battery life. * Battery usage varies according to the number of connected devices and level of activity;
- The Kajeet SmartSpot comes in two models to connect to either the Sprint or Verizon 4G LTE wireless networks;
- Supports the latest, most advanced security protocols required by some of the strictest school district VPNs, including IPv4 NAT and IPv6 Firewall, unique Wi-Fi password, MAC address filtering, Wi-Fi privacy separation and hacker prevention features;
